1. Bid prices will only be accepted based on a price per pound with a minimum bid \$0.25 per pound and a minimum bid quantity of 20 pounds and in 20 pound increments.
2. Material may be inspected on designed date as noted above at the Tucson ANG Base Recycling Center.
3. Pick-ups must be made at a negotiated date and time within 1 week after receiving load-ready notification by 162 EMO.
4. No bid deposit is required.

DEFAULT: If the Purchaser fails to pay for and or remove COMMODITY within the time allowed by this agreement, 162 WG Qualified Recycling Program will award sale to the next highest bidder.

RECYCLE PROPERTY: The Purchaser shall arrange with the 162 WG Qualified Recycling Manager for use of the facility and any government furnished equipment available for services. Purchaser shall not make changes to 162 WG Qualified Recycling Program owned facility or equipment. Should the purchaser desire to make changes the purchaser shall present the proposed change to the 162 WG Qualified Recycling Manager in writing, who will respond in a timely manner.

CONFIDENTIALITY: Any and all information made available to the purchaser/representatives as a result of this contract, shall be kept confidential. Failure to comply with this provision is a basis for termination of the sales agreement.
